 - b. the application forms and relevant attachments of the successful candidates will become part of the file which HKITJC opens and maintains for each member.
5. Under the provisions of the Personal Data (Privacy) Ordinance, applicants have rights to request access to, and to request the correction of, their own personal data. Applicants wishing to access or make corrections to their data should submit written requests to the Chairman of Membership Committee of the Hong Kong Information Technology Joint Council.

1 Membership Fee Schedule

- 1.1 A Bi-Annual Membership Fee of HK\$300 is required for Ordinary Membership.
- 1.2 A non-refundable one-off Administration Fee of HK\$100 is required for each Membership Application.

2 Membership Effective Period

- 2.1 An Annual Membership subscription fee is required to cover a 12-month period, i.e. with effect from either **January 1** for Members registered / renewed **between January 1 and June 30** or **July 1** for Members registered / renewed **between July 1 and December 31** of each year.
- 2.2 This application is for a 2-year membership subscription period.
